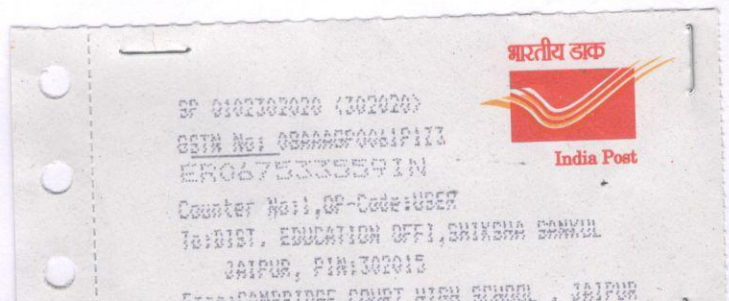

Notes:

1. A student will be considered as continuing in next session only on the payment of 1st installment of the fee by 10th April.
2. Fee shall be payable in 4 installments by 10th of April, July, October and January of the session.
3. A late payment charges @ Rs.100 per day (including Sunday/Holiday/Vacation) will be levied on payment of fee after dates mention herein.
4. Non-payment of installment by the last day of the month (April, July, October and January) will make the student entail for de-enrolment from the rolls of the school without any further notice.
